

Application to Register as Provider of Natural Gas Aggregation Service

Dear Mr. Trefethen:

On September 2, 2014, Summerview Energy, LLC (Summerview) filed an application with the Commission to renew its registration as a provider of natural gas aggregation service and requested that the application fees be waived based on special circumstances of its withdrawal and re-application. Staff recommended that the application be considered an initial application, but supported the request that the application fee be waived. Staff reviewed the application and determined that it is complete.

The Commission has determined that Summerview's filing is an initial application, grants its request for a waiver of the application fee based on the special circumstances, and approves Summerview's application effective as of September 8, 2014. The registration is for a term of two years and expires at the end of business on September 7, 2016. Pursuant to N.H. Code Admin. Rules Puc 3003.02(a), you must submit your next renewal application at least 60 days prior to the expiration of the registration approved here, on or before July 10, 2016.

Please be aware that registered providers of natural gas aggregation service are subject to specific requirements contained in N.H. Code Admin. Rules Puc 3000 – Competitive Natural Gas Supplier and Aggregator Rules. These rules are available at:

Please note that, effective as of July 1, 2014, each registered natural gas aggregator is subject to an annual assessment of \$2,000, unless it demonstrates that its gross revenue in New Hampshire during the preceding fiscal year (from July 1 through June 30) was less than \$10,000, pursuant to RSA 363-A:2, III and 5.
