Dear Ms. Battles:

On February 13, 2015, you filed an application to renew the registration of Sprague Operating Resources, LLC (Sprague Operating) as a provider of electric load aggregation in New Hampshire. On March 3, 2015, you filed a request to withdraw the application and to withdraw the currently active registration of Sprague Operating, which was approved under Docket No. DM 13-120.

The Commission's rules governing electric load aggregators do not provide for the withdrawal, rescission, or abandonment of an aggregator's registration. The Commission has reviewed your letter and has deemed it a request for waivers of N.H. Code Admin. Rules Puc 2003.04 (g) (approved aggregator registration valid for two years), and Puc 2003.04 (i) (registered aggregator to continue compliance with requirements of Puc 2000). The Commission has determined that the requested waivers, without any further conditions, are in the public interest and will not disrupt the orderly and efficient resolution of matters before the Commission, and that the purpose of the rules will be satisfied by the termination of Sprague Operating's electric load aggregator registration, effective as of the date specified in the request letter.

Accordingly, Sprague Operating's electric load aggregator registration is deemed withdrawn and terminated, effective as of March 3, 2015. Docket No. DM 15-063 has been closed.
