# LIBERTY UTILITIES (ENERGYNORTH NATURAL GAS) CORP., d/b/a LIBERTY UTILITIES

### **Cast Iron/Bare Steel Replacement Program Results**

#### **ORDER OF NOTICE**

On April 15, 2015, Liberty Utilities (EnergyNorth Natural Gas) Corp., d/b/a Liberty Utilities (Liberty) filed with the Commission its fiscal year 2015 (April 1, 2014, to March 31, 2015) Cast Iron/Bare Steel (CIBS) Replacement Program Results. As a result of work completed in fiscal year 2015, Liberty seeks a permanent increase in its base distribution rates of \$311,610 effective July 1, 2015. The program results and request for a rate increase are filed pursuant to the settlement agreement in Docket No. DG 11-040 approved in *National Grid USA*, Order No. 25,370 (May 30, 2012). The petition and subsequent docket filings, other than any information for which confidential treatment is requested of or granted by the Commission, will be posted to the Commission's website at http://www.puc.nh.gov/index.htm

Liberty's filing includes a report on actual cast iron/bare steel capital spending for fiscal year 2015, a request for a \$311,610 increase in the annual revenue requirement to be recovered through distribution rates effective July 1, 2015, and an explanation of variances from the fiscal year 2015 budget. Liberty calculated that the proposed revenue requirement increase would add \$1.50 to the \$1,309 total annual bill for a typical residential heating customer who uses 800 therms per year, 0.11 percent increase.

The filing raises, *inter alia*, issues related to whether Liberty's filing conforms to the requirements of the pertinent settlement agreements, whether Liberty has appropriately

accounted for the costs of the CIBS replacement program, whether Liberty's CIBS-related forecasts, budgets, and actual expenditures are reasonable and appropriate, whether Liberty has applied appropriate cost-control methods to its CIBS replacement program planning and construction work, matters related to "road degradation" fees assessed by certain New Hampshire municipalities located in Liberty's service area, road-resurfacing related "carry-over" costs, potential improvements to the CIBS filing review process, and whether the resulting rates are just and reasonable as required by RSA 378:5 and RSA 378:8. Each party has the right to have an attorney represent the party at the party's own expense.

## Based upon the foregoing, it is hereby

**ORDERED**, that Liberty, Staff of the Commission, and any intervenors hold a technical session at the premises of the Commission located at 21 S. Fruit St., Suite 10, Concord, New Hampshire on May 15, 2015 at 9:00 a.m.; and it is

**FURTHER ORDERED**, that a hearing be held before the Commission located at 21 S. Fruit St., Suite 10, Concord, New Hampshire on June 4, 2015, at 9:00 a.m.; and it is

**FURTHER ORDERED**, that pursuant to N.H. Code Admin. Rules Puc 203.12, Liberty shall notify all persons desiring to be heard at this hearing by publishing a copy of this Order of Notice no later than May 1, 2015, in a newspaper with general circulation in those portions of the state in which operations are conducted, publication to be documented by affidavit filed with the Commission on or before May 13, 2015; and it is

**FURTHER ORDERED**, that pursuant to N.H. Code Admin. Rules Puc 203.17, any party seeking to intervene in the proceeding shall submit to the Commission seven copies of a Petition to Intervene with copies sent to Liberty and the Office of the Consumer Advocate on or before May 12, 2015, such petition stating the facts demonstrating how its rights, duties,

privileges, immunities or other substantial interest may be affected by the proceeding, as required by N.H. Code Admin. Rules Puc 203.17 and RSA 541-A:32, I(b); and it is

**FURTHER ORDERED**, that any party objecting to a Petition to Intervene make said objection on or before May 15, 2015.
