To the Parties:

Late petitions to intervene were filed in this docket by Pentti J. Aalto, Michael Vose, SunRaise Investments LLC, and the Business and Industry Association of New Hampshire. The Commission has granted the petitions to intervene filed by Pentti J. Aalto, SunRaise Investments LLC, and the Business and Industry Association of New Hampshire.

The Commission has denied the petition to intervene filed by Michael Vose. Mr. Vose is not a ratepayer of any of the electric distribution utilities that are mandatory parties in this proceeding, and he does not have any rights, duties, privileges, immunities or other substantial interests that may be affected by the proceeding, nor does he qualify as an intervener under any provision of law, pursuant to RSA 541-A:32, I (b). Nevertheless, denial of Mr. Vose's intervention request should not prevent his participation in this docket. Mr. Vose has access to all docket and other related materials on the Commission's website and may make public comments at the hearing or file written comments, pursuant to N.H. Code Admin. Rules Puc 202.06 and Puc 203.18.

On June 22, 2016, parties and Commission Staff met in a technical session and agreed upon the following short-term procedural schedule, which Staff submitted to the Commission by letter dated June 24, 2016:

In addition, the Commission has scheduled a further technical session to be held in this proceeding at the Commission's offices on July 21, 2016, beginning at 9:00 a.m.
