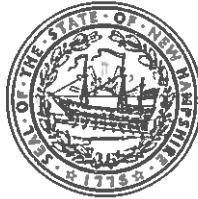

Re: REC 16-836 AlsoEnergy Request for Waiver of Puc 2505.09(i)(1), Puc 2505.09(a), and Puc 2505.09(g) Requirements for Independent Monitors

Dear Mr. Vue:

On October 17, 2016, the Commission received an application from AlsoEnergy, Inc. (Also Energy) requesting approval as an independent monitor under the Puc 2500 rules regarding the Renewable Portfolio Standard (RPS). AlsoEnergy proposes to implement a remote monitoring and reporting process that varies in certain respects from the process contemplated by the Puc 2500 RPS rules. Staff reviewed the application and recommended that AlsoEnergy file a letter requesting waiver requests for specified rules as discussed in more detail below. AlsoEnergy submitted a letter requesting waivers from three specific rules on December 19, 2016, and provided clarifying information in subsequent email communications.

AlsoEnergy provides a PV independent monitoring and reporting service that delivers comprehensive monitoring and control solutions. AlsoEnergy accesses and collects energy production through a production meter taking measurements directly from the system's AC current lines. AlsoEnergy's system detects any anomalies in meter data and generation data is uploaded to NEPOOL-GIS when all issues are resolved and its REC reporting team confirms data are valid. Upon confirmation, AlsoEnergy reports production directly to the NEPOOL-GIS. According to AlsoEnergy, the company currently provides independent monitoring services for projects in Massachusetts, Connecticut, Vermont, and Rhode Island.

In order to implement its business model for independent monitoring and solar generation reporting, AlsoEnergy requested waivers from three specific rules applicable to independent monitors: Puc 2505.09(i)(1) (initial on-site inspection requirement), Puc


2505.09(g) (monitor cannot have sold the installed system or associated equipment), and Puc 2505.09(a) (customer's direct retention of independent monitor's services).

Commission Staff reviewed and evaluated the AlsoEnergy rule waivers requests and additional clarifying communications, and Staff filed a memorandum on March 27, 2017 summarizing its review and recommending that the Commission grant the three requested rules waivers to permit AlsoEnergy to implement its remote electronic monitoring process in New Hampshire.

The Commission has reviewed the AlsoEnergy rules waiver requests and Staff's recommendation and has determined that the requested waivers of Puc 2505.09(i)(1), Puc 2505.09(g), and Puc 2505.09(a) would serve the public interest and would not disrupt the orderly and efficient resolution of matters before the Commission, as required under Puc 201.05. In determining the public interest would be served by such rules waivers, the Commission found that the purpose of the rules would be satisfied by the alternative methods proposed.

Accordingly, AlsoEnergy is granted a waiver from the relevant provisions of Puc 2505.09(i)(1), Puc 2505.09(g), and Puc 2505.09(a).
