Dear Ms. Howland:

On February 17, 2017, Commission Staff served its first set of data requests on the joint petitioners in this proceeding. On February 27, 2017, the joint petitioners separately submitted extensive and detailed objections to a majority of the data requests propounded by Staff.

Pursuant to the approved procedural schedule for the docket, Staff would be required to file a motion to compel with respect to those objections by the close of business today. However, additional substantive responses to Staff's data requests are expected to be provided this afternoon, and the parties also intend to make a final attempt to resolve their outstanding discovery issues before a motion is filed.

Staff therefore requests that the Commission approve an extension of the applicable deadline for filing a motion to compel discovery responses until March 8, 2017. None of the parties has objected to the proposed deadline extension.
