Please accept an original and two copies of this letter for filing with the New Hampshire Public Utilities Commission ("Commission") as a request by Northland Telephone Company of Maine, Inc. (the "Company") for approval to effectuate a name change in Northland Telephone Company of Maine, Inc.'s fictitious business name from FairPoint Communications/Northland Telephone Company of Maine, Inc. to Consolidated Communications/Northland.

By this letter, Northland Telephone Company of Maine requests a letter of authorization from the Commission changing its certificated name from Northland Telephone Company of Maine, Inc. d/b/a FairPoint Communications/Northland Telephone Company of Maine, Inc. to Northland Telephone Company of Maine, Inc. d/b/a Consolidated Communications/Northland, with an effective date of February 19, 2018. The new d/b/a is to be reflected in all company references, including all operating authorities granted to the Company by the Commission.

The Company is filing a revised tariff Title Sheet for Access Service Tariff No. 2 to reflect the new name Northland Telephone Company of Maine, Inc. d/b/a Consolidated Communications/Northland and requesting an effective date of February 19, 2018 for this page, contemporaneously with this name change request.
