

The interest rate is based on the three month London Interbank Offer Rates (LIBOR) on the first business day of the month.

Billing Adjustment: Refund provided to an outdoor lighting customer from 2014. The total SBC amount was \$199.64. The total EAP amount refunded was \$84.64. The monthly billed kWh shown on this report do not reflect the refund because the customer's bill was not canceled and rebilled, which would then include the kWh in the monthly revenue report, the customer was only provided a monetary refund.

^[1] Customers taking service under TOU Rate D-10 are only eligible to receive a discount on 750 kWh. For customers using more than 750 kWh on or off peak, the bill must be adjusted to acccommodate the parameters of the EAP program. The billing system is unable to make this adjustment on its own. The Billing dept creates the adjustment to the customer's bill. The Finance dept creates a journal entry to the GL to record the adjustment.

^[2] The >750 kWh are informational only.
