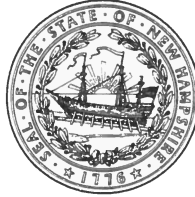

Affiliate Contract – Money Pool Agreement

Dear Mr. Sheehan:

On December 1, 2017, Liberty Utilities (EnergyNorth Natural Gas) Corp. and Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty Utilities (Liberty), filed a money pool agreement between Liberty Utilities Co. (LUCo) and several subsidiaries of Liberty pursuant to RSA 366.3. Liberty stated that the purpose of the agreement is to create a money pool to enable LUCo subsidiaries to borrow funds from and lend funds to the pool on a short-term basis.

This letter serves as an acknowledgement that Liberty, pursuant to the requirements of RSA 366:3, have filed contracts between a public utility and an affiliate for the provision of services in exchange for compensation that exceeds \$500. This acknowledgement does not constitute approval of any rate or revenue requirement change that may be claimed as a result of the service provided for in the filed documents. As any issue that may arise under the contract may be addressed in another docket or through the opening of a new docket, the Commission will not open an investigation at this time under RSA 366:5 and has closed this docket. As you may be aware, any modifications of the contract must also be filed with the Commission pursuant to RSA 366:3.
