This letter is to inform the Commission that EnerNOC, Inc. has recently changed its name. As indicated in the pre-filed testimony of Messrs. Geller and Perry, EnerNOC, Inc., is now a subsidiary of Enel. As part of that affiliation with Enel, in October, EnerNOC officially changed its name to Enel X North America, Inc. Attached is a copy of EnerNOC's name change request filed with the New Hampshire Secretary of State. Enel X North America, Inc. remains authorized to conduct business in New Hampshire and adopts the petition and testimony previously filed under its former name as its own.

As stated at the prehearing held on November 8<sup>th</sup>, this name change does not change the substance of the petition and pre-filed direct testimony. The individuals and services described in the petition and testimony remain the same.
