On October 19, 2018, Demco Energy LLC (Demco Energy) submitted an application with the Commission to renew its registration as a provider of electric aggregation service.

Staff recommended that Demco Energy's registration renewal application be approved for a two-year term, beginning on December 19, 2018, pursuant to Puc 2003.06(e)(1).

Your application for registration renewal is approved effective as of December 19, 2018, under Puc 2003.06(e)(1). The renewed registration is for a term of two years and expires at the close of business on December 19, 2020. Pursuant to Puc 2003.06(a), you must submit your next renewal application at least 60 days prior to the expiration of the approved registration term, on or before October 20, 2020.

Please be aware that registered providers of electric aggregation service are subject to specific requirements contained in N.H. Code Admin.
