**Re: DT 19-041: Petition of Consolidated Communications of Northern New England Company, LLC For Approval of Modifications to the Wholesale Performance Plan**

Dear Ms. Howland:

On February 28, 2019, Consolidated Communications of Northern New England Company, LLC d/b/a Consolidated Communications – NNE (“Consolidated Communications”) submitted a petition requesting the New Hampshire Public Utilities Commission (“Commission”) approve certain modifications to the Wholesale Performance Plan (“WPP”) for effect June 1, 2019. That filing included a redlined copy of the WPP reflecting Consolidated Communications’ proposed revisions as described in the petition.

Consolidated Communications subsequently discovered that some edits were not reflected in the earlier filed redlined WPP. The “missing” edits or corrections are shown on pages 10, 11, 16, and 114-117 of the attached revised redlined WPP and are highlighted in yellow. All un-highlighted redlined changes should have appeared in the proposed WPP revisions filed on February 28, 2019.

None of the highlighted corrections represent a new proposal. Corrections on pp 10-11 tie the references to the correct Table number (correcting a typo). A correction in footnote 13 on page 16 is consistent with similar changes proposed in footnotes 9, 10, and 12. Corrections on pages 114-117, Appendix 2, appear in the fifth column titled “Performance Credit Method” and apply to seven metrics (one UNE DS3 and six UNE Trunk metrics). These corrections are consistent with related changes previously set forth in the metric guidelines section for the same metrics.

Consolidated Communications is submitting an electronic copy of this filing via email. Pursuant to Puc 201.05, Consolidated Communications respectfully requests the Commission waive Puc 203.02(a)(1), which requires an original and six paper copies of all documents to be filed with Commission. In support of this request Consolidated Communications states that the redlined version of the WPP is voluminous and therefore requests leave to limit the number of paper copies to be filed to an original and one paper copy.
