
Re: DE 19-064, Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty Utilities

Cancellation of March 10, 11 and 26 Hearings

To the Parties:

By Secretarial Letter dated February 28, 2020, the Commission granted Commission Staff's (Staff) request to revise the current procedural schedule in the above-captioned matter so that hearings were scheduled on March 10, 11, 26, 27 and 31, 2020, to permit the parties to continue settlement negotiations. On March 6, 2020, Staff filed a letter requesting the cancellation of hearings scheduled on March 10, 11, and 26, stating that the parties continue to negotiate and substantial progress has been made toward reaching a comprehensive settlement. Staff noted that all of the parties have assented to this request.

Accordingly, the Commission has cancelled the March 10, 11, and 26, 2020 hearings. Hearings remain scheduled for March 27 and 31, 2020, at 10:00 a.m.
