Petition for Permanent and Temporary Rates  
Cancellation of April 7, 2020 Hearing

To the Parties:

On April 6, 2020, Commission Staff (Staff) filed a letter requesting the Commission to cancel the hearing scheduled on April 7, 2020 on the merits of a comprehensive settlement that the parties have been discussing. Staff noted that Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty Utilities (Liberty) agreed to waive its right under RSA 378:6, I(a) to an investigation of its proposed tariff within 12 months and to implement permanent rates to take effect July 1, 2020, which Liberty confirmed in a letter to the Commission filed on April 6. Staff requested the Commission to schedule a hearing during the week of May 4, 2020 to consider a settlement regarding permanent rates effective July 1, 2020. Staff stated that all parties concurred with this request.

Accordingly, the Commission has cancelled the April 7, 2020 hearing. Staff shall advise the Commission on or before April 21, 2020 of the dates and times during the week of May 4, 2020 that all parties will be available for a hearing.
