On July 11, 2019, representatives of Eversource Energy, the Office of the Consumer Advocate, Clean Energy NH, Conservation Law Foundation, and Commission Staff met in technical session to discuss preliminary issues relevant to this proceeding, including the development of a procedural schedule for the docket.
