Amendment of Filing Deadlines

To the Parties:

On May 29, 2020, the Office of the Consumer Advocate (OCA) filed a letter requesting the Commission to postpone the following filing deadlines approved by secretarial letter dated May 12, 2020: the June 3, 2020 deadline for filing memoranda of law; and the June 18, 2020 deadline for filing reply briefs. The OCA stated that Abenaki Water Company, Inc. (Abenaki), Omni Mount Washington Hotel, LLC, Bretton Woods Property Owners Association, and Commission Staff assented to this request.

In its May 29 letter, the OCA requested postponement of the filing deadlines due to other matters scheduled on June 3. June 3 is also the date of the hearing on Abenaki’s motion to extend the Step II filing deadline in Docket No. DW 17-165.

Accordingly, the Commission has extended the deadlines for filing memoranda of law and reply briefs, as well as the June 3, 2020 deadline for filing a stipulation of contested facts, as follows, *see* N.H. Admin. R., Puc 202.04:

Memo of Law (Not to Exceed 15 Pages--Excluding Attachments)	July 14, 2020
Stipulation of Contested Facts	July 14, 2020
Reply Brief (Not to Exceed 5 Pages--Excluding Attachments)	July 28, 2020

The hearing will remain scheduled on Wednesday, August 5, 2020, at 10:00 a.m.
