On October 1, 2019, the Commission issued a secretarial letter approving a procedural schedule in the above-captioned docket. Pursuant to that schedule, the parties were set to have a technical session on November 19, 2019. On November 19, 2019 Public Service Company of New Hampshire d/b/a Eversource Energy (Eversource) filed an assented to motion to amend the procedural schedule, requesting to reschedule the November 19, 2019 technical session for January 17, 2020. The Commission approved Eversource's request via Secretarial Letter on November 21, 2019.
