

Joinder Agreement to Affiliate Services Agreement
Liberty Utilities Co.

This Joinder Agreement to the June 30, 2017, Affiliate Services Agreement (the “Affiliate Services Agreement”) is entered into and effective as of the 1st day of October, 2019, by and between Liberty Utilities Co., a Delaware corporation, (“LU Co.”) and Liberty Utilities (Gas New Brunswick) LP (“GNB”), Liberty Utilities (EnergyNorth Natural Gas) Corp., Liberty Utilities (Granite State Electric) Corp., Liberty Utilities (New England Natural Gas Company) Corp., Liberty Utilities (Peach State Natural Gas) Corp., Liberty Utilities (CalPeco Electric) LLC, Liberty Utilities (Park Water) Corp., Liberty Utilities (Apple Valley Ranchos Water) Corp., Liberty Utilities (Bella Vista Water) Corp., Liberty Utilities (Gold Canyon Sewer) Corp., Liberty Utilities (Litchfield Park Water & Sewer) Corp., Liberty Utilities (Black Mountain Sewer) Corp., Liberty Utilities (Entrada Del Oro Sewer) Corp., Liberty Utilities (Pine Bluff Water) Inc., Liberty Utilities (Rio Rico Water & Sewer) Corp., Liberty Utilities (Seaside Water) LLC, Liberty Utilities (Fox River Water) LLC, Liberty Utilities (Missouri Water) LLC, Liberty Utilities (Silverleaf Water) LLC, Liberty Utilities (Tall Timbers Sewer) Corp., Liberty Utilities (White Hall Sewer) Corp., Liberty Utilities (White Hall Water) Corp., Liberty Utilities (Woodmark Sewer) Corp., Liberty Utilities (Woodson-Hensley Water) Corp., Liberty Utilities (Midstates Natural Gas) Corp., The Empire District Electric Company, The Empire District Gas Company, and Empire District Industries, Inc. (each individually a “Liberty Utilities Entity” and collectively, the “Liberty Utilities Entities”). The parties to this Agreement are otherwise collectively referred to as the “Parties” or individually referred to as a “Party.”

WHEREAS, LU Co. owns, either directly or indirectly, the Liberty Utilities Entities, and provides certain services to those entities;

WHEREAS, GNB desire to obtain the benefits of the Affiliate Services Agreement; and


WHEREAS, LU Co. and the other Liberty Utilities Entities that are presently Parties to the Affiliate Services Agreement agree to GNB joining the Affiliate Services Agreement.

NOW, THEREFORE, the Parties agree as follows:

GNB acknowledges and agrees with the Parties that GNB is a signatory and party to the Affiliate Services Agreement as of the date written above and are thus subject to all the terms and conditions of the Affiliate Services Agreement applicable to each Party.
