Dear Mr. Kilbride:

On April 15, 2020, Devaney Energy, Inc. (Devaney) submitted an application with the Commission to renew its registration as a provider of natural gas aggregation service.

Commission Staff filed a memorandum on April 20, 2020, in which it confirmed its review of the application and its conclusion that the application meets the requirements for registration under N.H. Code Admin. Rules Puc 3000. Staff recommended that Devaney's registration application be approved for a five-year term, beginning on May 14, 2020.

The Commission has approved Staff's recommendation. Accordingly, Devaney's application for registration is approved, effective as of May 14, 2020. The renewed registration is for a term of five years and expires at the close of business on May 14, 2025. Pursuant to Puc 3003.05(a), you must submit your next renewal application at least 60 days prior to the expiration of the approved registration term, on or before March 15, 2025.

Please be aware that registered providers of natural gas aggregation service are subject to specific requirements contained in N.H. Code Admin. Rules Puc 3000 – Competitive Natural Gas Supplier and Aggregator Rules. These rules are available at:
