# Petition for Electric Vehicle Make-Ready and Demand Charge Alternative Proposals

### Procedural Order Re: Request for Hybrid Hearing

The Commission scheduled an in-person hearing in this matter on July 14, 2022. On June 16, 2022, Conservation Law Foundation (CLF) and Clean Energy New Hampshire (CENH) filed a joint request for remote participation by their consultant, Christopher Villarreal, who lives in Minnesota and whom they intend to call as a witness. CLF and CENH, which are both nonprofit organizations, have requested that Mr. Villarreal be permitted to participate remotely during the July 14 hearing to save the costs that would be incurred if he were required to travel to New Hampshire to appear in person. No objection to this request was filed.

CLF and CENH have provided good reason for Mr. Villarreal to appear remotely on July 14, 2022. Therefore, a hybrid hearing format will be used for the July 14 hearing to accommodate Mr. Villarreal only. Any other parties or witnesses wishing to appear remotely at the hearing are required to file a separate request.
