The Commission has scheduled a stakeholder session on June 27, 2019, starting at 9 a.m. at the Commission's offices, in order to discuss the performance of, and potential changes to, both the residential and commercial and industrial bulk-fed wood pellet central heating system rebate programs.

If it is determined during or following the session that changes to either or both programs are warranted, Staff would initiate the program modification process, which may include a technical session, Staff recommendation, public comment hearing and written comments on Staff's recommendation. Subsequent to the receipt of public comments, the Commission would determine the appropriate changes to be made to the bulk-fed wood pellet programs.
