2001 please accept this letter as the comments of Conversant Communications of NH, LLC. In proceedings in NH and RI, Conversant had proposed that additional metrics regarding the provisioning of DS-1 UNE loops be added to Verizon's PAP to address Verizon's practice of rejecting orders on the grounds that no facilities are available. At the hearing in RI, Verizon agreed, upon request, to convert month-to-month special access DS-1 facilities into DS-1 UNE loops after such special access circuits had been in place for three months and indicated that no additional non-recurring charges would apply. Based on Verizon's willingness to allow Clefs to convert special access facilities into DS-1 UNE loops, Conversant is no longer seeking additional DS-1 UNE metrics in this proceeding. Verizon has indicated that at least two additional billing metrics are being considered in NH. Conversant respectfully urges the Commission to order Verizon to amend the PAP to include these measures in the PAP for NH.
