The Company expects that there will be 47 customers when Phase 1 is fully developed. Also, on September 3, 2014 the NHPUC issued Order No. 25,713 approving recovery of rate case expenditures. The NHPUC approved a surcharge in the amount of \$20.60 per customer per quarter for eight billing periods.
